All electrical hook-ups are an additional \$5.00 per outlet for booths requiring electricity. Lights and extension cords NOT furnished.

Committee will assign booth space on a first come, first paid basis (based on electrical and hook-up needs, and other special considerations) ALL Fees are non-refundable. Space cannot be reassigned by anyone other than the committee and are non-transferable!

RULES:

1. Booth rental fee must be received in full and must be submitted with a completed application prior to setting up. You will be notified of your booth location one (1) week prior to the Festival. There will be NO swapping of booth spaces without the express written permission of festival coordinators. Remember the Booth Space dimensions (10' Wide X 12" Deep) and plan your booth accordingly. YOU will be required to move if you set up your booth in a designated space other than your own, you may be asked to move.
2. Vendor Set up time will begin on Friday, September 7, 2007 from 4:00 PM- 8:00 PM. with final set up on Saturday morning September 8, 2007 from 7:00 AM-9:00 AM. ALL Vehicles must be off the Field by 9:00 AM on Saturday. You are encouraged to set up your booth on Friday Evening, and committee is not liable for your belongings. We will have Security on the premises Friday evening, overnight and Saturday.
3. All booths will be located on the athletic field. Bring your own water. Water hook-up NOT available.
4. All FOOD booths without floors must cover the ground with drop paper. Food Booths will be located in Designated Food areas. Grease must be dumped in a designated area. No beverage sales permitted.
5. You are responsible for your own extension cords, tables, lights and other equipment. The Committee will not be responsible for any lost, stolen or damaged property, or any accidents that may occur.
6. You must provide your own cover-ups.
7. You are responsible for keeping your area clean during the festival and you must clean your space before you leave or a \$25.00 Cleaning Fee will be charged.
8. No cars, trucks, or trailers will be permitted to park on the athletic field without specific permission from the festival organizers. Vendor parking will be designated during the festival.
9. Absolutely NO fireworks, snap & pops, stink bombs, smoke bombs, stink sprays, silly string, hair coloring, and shaving cream or like items will be permitted to be sold or distributed. ABSOLUTELY NO ALCOHOLIC BEVERAGES! This is School Property; weapons, drugs and/or alcohol not permitted.
10. The Committee reserves the right to approve or deny the participation of the applicant.
